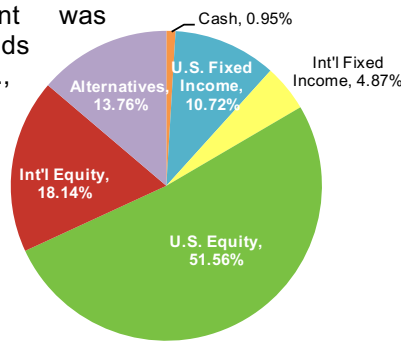


## Annual Endowment Summary

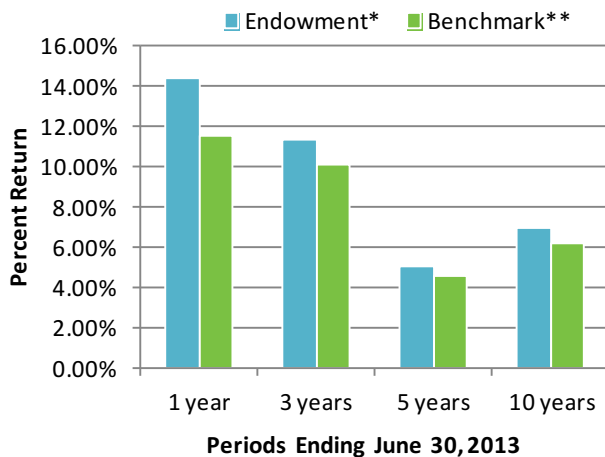
### Asset Allocation

As fiscal year 2013 came to a close, the **Foundation's Endowment remained broadly diversified across equity, fixed income, and alternative investments.** Nearly 70% was invested in mutual funds containing equities (i.e., stocks) with exposure to international markets and various investment styles. Approximately 17% of the Endowment was positioned in mutual funds containing fixed income (i.e., bond) securities and cash, and the remainder of the portfolio was invested in mutual funds containing alternative assets, such as energy, natural resources and commodities.



### Performance

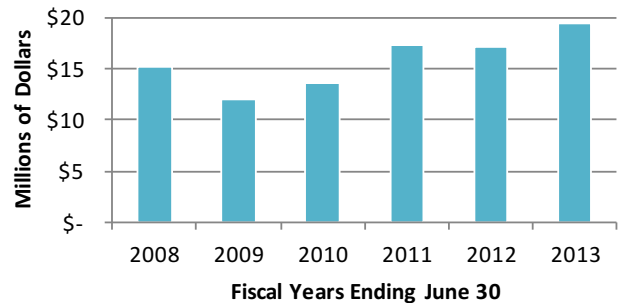
**Performance of the Endowment in fiscal year 2013 was 14.4%, outperforming the benchmark (11.5%).** Most equity asset classes had double digit returns for the year. Domestic equities outperformed international equities for the year, but well outperformed them over the last six months. **The Foundation remains confident it is investing to both preserve and grow the Endowment for the long-term.**

### Endowment Value

The total value of the Endowment also grew in fiscal year 2013. **Endowed assets increased by nearly \$2.4 million due mostly to the positive returns of equities.**



### Investment Policy Summary

**The Endowment is invested according to guidelines established by the Board of Directors in the Investment Policy Statement.** This policy is reviewed regularly with an external consultant so that the investment strategies used for the Endowment are kept in compliance with the policy statement.
