

2021 "Creating Community" Grant Initiative Guidelines

Purpose

Each and every day, the Community Foundation strives to improve the lives of people who live, work, learn, and play in Monroe County. Through strategic grantmaking, the Foundation fuels innovative ideas and lasting impact by granting funds to meet our community's most pressing needs and seize its most compelling opportunities. For over 30 years, the Community Foundation has funded projects and programs that are forward thinking, community changing in their implementation, practical in their application, and uniquely relevant to the community.

<u>Purpose</u>

CFBMC, with the support of funding generously provided by the Smithville Charitable Foundation, is pleased to announce the "Creating Community" grant initiative and invites local organizations to submit proposals. These grants are intended to foster our community's vibrancy, quality of place, and livability through supporting and enhancing the amenities that make Monroe County an attractive place to call home. Examples of eligible proposal areas include but are not limited to: the arts, public recreation, community spaces, beautification, animal welfare, environmental preservation and enhancement, and opportunities to create a more welcoming, inclusive Monroe County.

Our community has generously worked to address many basic needs during the last year and a half. The Community Foundation, along with federal, state, and other local funders has provided, and will continue to support critical funding to support human and social service needs resulting from the pandemic. For the fall 2021 grantmaking cycle, the Foundation seeks to complement this funding through a focus on restoring and enhancing the overall livability of our community.

The Foundation will continue to monitor community needs and opportunities and respond accordingly through aligned grantmaking strategies, as we have throughout the pandemic. We currently anticipate multiple grantmaking cycles, the first in fall 2021 followed by a second in spring 2022. This schedule may change if circumstances make it prudent or necessary.

Grant Funds Available

Range of grant awards: \$10,000 to \$25,000 per proposal

Total grants: 6-15 awards expected

Process and Timeline

September 8, 2021 Announcement of grant cycle; application opens

October 25, 2021 Application deadline

December 3, 2021 Announcement of awards

Mid-December 2021 Grant funding available (pending grant agreement)

Eligibility

Applications may be submitted by local 501(c)(3) nonprofits and other organizations that are exempt from filing for a 501(c)(3) status. This includes units of government, school corporations, and religious organizations. Grants may be awarded to religious organizations for programs that are non-proselytizing and do not promote religious doctrine or instruction. In limited situations, CFMBC may be able to grant to other types of organizations that are serving a charitable purpose but do not have a 501(c)(3) status. Application access

Eligible organizations should complete an application for funding via the online portal found at https://cfbmcgrants.communityforce.com/Login.aspx

Direct costs for implementing the project or program are eligible grant expenses. In addition, no more than 30% of the requested grant funding may be used for indirect costs that contribute to the organization's ability to implement the grant project, or for building and/or sustaining operational capacity for the duration of the grant period. Examples of indirect operating expenses related to the project may include areas such as fund development, internal operations such as IT upgrades, financial management tools, administrative costs, essential staffing, and core program costs.
